- Bids are invited under PPRA Rules 2014 (amended to-date) based on Market Rates System 1st Bi-Annual period (1st January 2024 to 30th June, 2024) District Sargodha of Rates approved by the competent authority from the approved contractors of the Irrigation Department who have got their names enlisted / renewed in appropriate category for the current financial year 2024-25.
- 2. In accordance with Administrative Department Notification No. SO (EVL) Irri/1-1/2010 dated 22.01.2024 a complete set of Tender Documents can be purchased from the office of the Executive Engineer, Bhalwal Canal Division Bhalwal at Sargodha (Secretary Tender Opening Committee Zonal Level) on or before 07.08.2024(Wednesday) by interested bidders on submission of a written application to the above office upon payment of a non-refundable fee of Rs.35000/- (Rupees: Thirty Five Thousand Only) up to 3.00 PM. No tender documents shall be sold on the date of receipt of tenders.
- 3. The tender form IB-386/ tender documents will be received by the Tender Opening Committee on Most of the Chief Engineer, Sargodha Irrigation Zone, Sargodha. The tender will be opened on the same day at 01:00 PM in the presence of contractors or their authorized representatives who care to remain present on the occasions. In case of postponement due to holiday announced by the District / Provincial / Federal Government, tender will be received and opened on next working day.
- 4. The contractors / firms who desire to obtain tender form/ tender documents shall have to furnish the original documents to The Executive Engineer, Bhalwal Canal Division Bhalwal at Sargodha (Secretary Tender Opening Committee Zone Level) including Enlistment / Renewal of their names with Irrigation Department & Pakistan Engineering Council for the current financial year 2024-25, Government receipts for payment of Professional Tax, Enlistment / Renewal Fee Registration with the Punjab Revenue Authority (PRA) for the year 2024-25, CNIC, Original Power of Attorney(valid) on appropriate stamp paper i-e Rs. 2000/- issued by the BOP with date of issuance and validity along with photo copy of CNIC of proprietor of the firm. The photo copy of the same documents should also be provided at the time of getting tender form / tender documents. In case of any missing document, tender will not be issued to the contractor/ firm. The Executive Engineer, Bhalwal Canal Division Bhalwal at Sargodha (Secretary Tender Opening Committee Zonal Level) will issue the tender form/ tender documents after his entire satisfaction and verification of all documents.
- Only Contractors/ authorized person having power of attorney can purchase/ attend bid opening meeting/sign the financial bids as required under Clauses 16 of "General Directions for Guidance of the Tenders".
- 6. The tender must be delivered by the intending bidders in person or through their authorized representative to the Tender Opening Committee in sealed envelope. Tenders received by post or through any other means shall not be entertained / accepted.
- 7 The conditional, incomplete & overwritten tender submitted by the bidders will be considered as rejected.
- 8. All the bidders must sign each page of bidding documents.
- 9. All the bidders must fill and sign the Tender Form/ Application Form.
- 10. The Procuring Agency/ Tender Opening Committee may reject all bids or proposals at any time prior to the acceptance of a bid or proposal, the grounds for its rejection shall be communicated upon request to any contractor who submitted a bid or proposal, but it is not required to justify those grounds.
- Earnest money @ 5% of the estimated cost of work preferably bank guarantee / in the shape of Deposit Call, drawn in favor of the Executive Engineer, Bhalwal Canal Division Bhalwal at Sargodha from any scheduled bank must accompany the tender, failing which tender will not be entertained/accepted.
- 12. All the bidders should satisfy themselves about site, location, conditions prevalent at site and its accessibility because immediately after issuance of letter of acceptance from the Executive Engineer, Bhalwal Canal Division Bhalwal at Sargodha, (Secretary Tender Opening

Committee Zonel Level) the contractor will have to mobilize to the site of work within seven days and to start the work at site.

- In case of tender rate less than 5% of the Technical Sanctioned amount, the lowest bidder will
 have to deposit additional performance security / quality assurance security as per Finance
 Department, Government of Punjab, Lahore Notification No.RO (Tech)FD1-2/83/VI(PPP) dated
 06.04.2005, No.RO (Tech) FD1-2/83/VI(P) dated 24.01.2006 and No.RO(Tech)FD1-2/2010 dated
 04.09.2012 prescribed therein.
- 14. In accordance with Government Of Punjab Finance Department Notification No. RO(TECH)FD1-2/2017 dated 16-11-2022, General direction No. 26(A). In case the total tendered amount is equal to or less than 5% of the approved estimated (DNIT) amount, the lowest bidder will have to deposit quality assurance security from the schedule bank equal to the amount of difference between approved DNIT amount and the quoted bid amount, within 15 days of issuance of notice or within expiry period of bid, whichever is earlier.
- The work will be executed according to specifications approved design / drawings approved by competent authority and P.W.D specifications.
- 16. The Contractor will have to submit the Construction Schedule for completion of work within stipulated period. In case of failure, the contractor will have to pay compensation as per relevant Clauses of Contract Agreement.
- 17. The payment will be made as per actual work done after deduction as per departmental rules, subject to the clearance of works by the ADP Consultants, departmental committee or any other agency and subject to availability of funds.
- 18. No interest shall be paid to the contractor on account to any delay in making payment by the department for the work done by him.
- 19. The contractor have no right to claim any interest on account of delay in making the payment of the work done, due to non-receipt of funds in time.
- 20. The Deposited at Calls of 2nd & 3rd lowest bidders will be released after approval of tenders by competent authority.
- 21. If two or more contractors/ firms become the lowest by quoting the same rates for this work, the decision of competent authority to accept the tenders for award of contract will be final.
- 22. In case of any dispute, the matter shall be referred to the H'able Secretary, Irrigation Punjab, Lahore whose decision will be final and binding for both parties.
- 23. The successful bidder will have to execute an agreement with the Executive Engineer, Bhalwal Canal Division Bhalwal at Sargodha (Secretary Tender Opening Committee Zone Level) within 07 days of issuance of acceptance letter.
